## <u>Power Golf Cart Rental Agreement</u>

This agreement shall apply to all memberships & rentals of golf carts provided by the Walkerton Golf & Curling Club (herein "the Club"). In consideration for the rental of any golf cart(s) provided by the club, I agree to the following conditions:

- 1. I am familiar with the safe operation and use of the golf cart and any other instructions provided to me regarding the golf cart, including any policies pertaining to the proper use of golf carts on property of the club, and will operate the golf cart in accordance with said instructions and policies. I agree to contact the club should I have any questions or concerns about operating the golf cart.
- 2. I agree that only persons who are 18 years of age or older with a valid driver's licence shall be permitted to drive the golf cart. I further agree that I will not authorize anyone who is not familiar with the safe operation and use of the golf cart and any other instructions provided regarding the golf cart, including any policies pertaining to the proper use of golf carts on property of the club.
- 3. I will operate the golf cart safely and responsibly, and I will preserve and protect the golf cart from loss or damage to the cart itself, my person or property, and the persons or property of others.
- 4. I agree that the maximum occupancy of the golf cart is two persons, including children.
- 5. I agree that should I be injured fatally or otherwise, for whatever reason while riding in or driving a golf cart, I cannot sue the Club, its management, directors, employees, volunteers, or members. I agree to this for not only my first golf cart rental, but also for any golf cart rentals I may make in the future. I agree to hold harmless, defend and indemnify the club and/or its management, staff, and directors for all damages and claims of any nature whatsoever that may arise from the use of said golf cart by myself or others authorized by me, including but not limited to claims for damages to the golf cart itself, my person and property and the persons and property of others. I further agree to reimburse the club for any unrecovered costs, including but not limited to deductibles and any uninsured losses.
- 6. If I violate any of the above conditions, I agree that the privilege of using the golf cart can be revoked without notice by the Walkerton Golf & Curling Club in their sole discretion. I further agree I shall not be entitled any rental or membership refund for such revocation of privilege and acknowledge that the privilege of future use of a golf cart on the property of the club may be suspended or revoked.
- 7. I agree that this golf cart rental agreement is made with the club and is in effect for all golf cart rentals until cancelled in writing by me or by the club; provided, however, that clause 5 here of shall survive cancellation for any damages or losses occurring while this agreement was in effect.
- 8. I certify that I understand and agree to the conditions set forth above. I acknowledge that I have signed this document voluntarily and freely and that my signature creates a contractual obligation that binds me, my heirs, and successors.

I understand and agree that the Walkerton Golf and Curling Club may use my name and or post my image from time to time at the club, in golf or local media outlets/publications, and/or posted within the Walkerton Golf and Curling Club website or social media pages.
